#### MINUTES OF THE MEETING - HELD AT DIPTFORD PARISH HALL TQ9 7NY

# ON TUESDAY 15<sup>th</sup> July 2025 @ 6.30pm

# 1) Open Forum – Public & Parishioners (15 minutes) –

a) Chairman Cllr Sue Franklin opened the meeting - Morrish homes cancelled yesterday at late notice, the representatives were unable to all make it to the meeting to discuss their new plans for Wheat Park, Diptford. They have confirmed they will come to a future meeting possibly in September but this is to be confirmed.

A brief History of the site — the site was zoned for housing over 20 years ago by SHDC, the site was never gifted to the Parish Council, it has never been in the ownership of the Parish Council, it was sold on the open market and a planning application in 2012 by the company who bought it for 15 dwellings with 5 affordable for people with a local connection was put in. The first full application was approved in 2013, for the 15 dwellings which were not built and in 2018 another application was made for 12 dwellings with 4 affordable this application was also approved in 2018 and later a certificate of lawfulness was made by Morrish Homes for the commencement of the site. It now seems as though they want to revert back to 15 homes on site — but in what style or design is currently unknown as no plans have been viewed.

- b) Planning application -8a) The applicant was present and confirmed that sales made from the site are online sales and at local markets, there is no proposal to have a shop on the site so the traffic will not increase except during the build. Currently there is a temporary dwelling on site which has 3 years granted, and this is now an application for a permanent dwelling on site.

  - d) Tree Warden Tree overhanging gate on footpath 1 needs cutting back.
