Diptford Parish Council Remote Meeting Tuesday 12 May 2020 7.30 pm Following the AGM of the council MINUTES

Report from Cllr Smerdon (SHDC)

Cllr Smerdon also reported that the carparks at Bigbury and North Sands beach would be opening Friday 15th May - phone only payments at present and that the toilets would open 22nd May. Car parking in towns is to remain free for the present.

More would be opening on a rolling programme.

Report from Cllr Hosking (DCC)

Cllr Hosking has been sending regular updates through to the council over the month. He thanked Rev. Sayle for all his efforts co-ordinating the emergency support volunteer programme in the parish. He reiterated that there was emergency funding still available and urged anyone who needs support of any kind to contact him. He reminded council that the recycling centre in Ivybridge was now open for essential waste only and warned that long queues were expected in the first few weeks. There is still funding available through his locality grant.

Cllr Hosking has proposed the Primrose Line for a feasibility study into re-opening the line. Comments are welcome.

CP commented that it would probably only be used for recreational purposes.

SPD commented that it would be an asset to the parish if opened for recreational purposes SF commented that she felt the benefits might not justify too great expenditure on the feasibility study.

SF asked what was happening during the pandemic period with road repairs. Cllr Hosking confirmed that work is progressing as normal as possible.

A member of the public gave further details of the planning application 1015/20/FUL. The emphasis for the build is energy efficiency, longevity and sustainability. SF congratulated him on the design and access statement.

SF had been asked to raise 2 issues by members of the public:

- The rooks nesting in the trees in the playing field causing a nuisance and mess. It was agreed that the problem would ease after the nesting season and that while rooks are not granted any specific legal protection the Wildlife & Countryside Act 1981 protects all birds, their nest and eggs making it an offence to intentionally damage or destroy an active nest or prevent parent birds access to their nests.
- Could the village hall committee give reassurance that prior to opening it would be deepcleaned? SH confirmed that plans were already in place for this to happen – a company still needs to be found and plans confirmed for continual cleaning pending further government

advice. The hall will only open to the school initially and the committee is waiting to hear from the school re a proposed re-opening date.

- 2020/19 There were no apologies for absence (SF took the Chair as JF was having technical difficulties and the council were unable to hear him.
- 2020/20 LL registered an interest in item 2020/24 b) on the agenda.
- 2020/21 The Minutes of the Meeting held on the 14th April 2020, as previously circulated, were confirmed and will be signed by the Chair
- 2020/22 Highways and Community Lengthsmana) It was agreed that SPD would ask the Lengthsman to start on road-sign cleaning.

It was agreed that this was an attractive design fitting into the landscape and councillors were impressed with the efforts to ensure energy efficiency and sustainability.

b) Discussion regarding correspondence from a parishioner regarding Holsome Park

LL retired to the waiting room and did not participate in these discussions. It was noted that this communication was an on-going issue over several years. DPC has been assured by the owners of the property the parishioner is complaining about that the issues raised are being addressed in the relevant planting seasons when the ground is not water-logged as it was during this last winter. It was agreed that the issue needed to be dealt with by SHDC as the planning authority and that DPC were unable to consider the matter again. Cllr Pannell will check with Planning and Development that the previous correspondence was dealt with and the clerk will inform the parishioner that this matter cannot be dealt with by DPC and he needs to seek the advice of SHDC.

2020/25 The following planning decisions made by SHDC were noted and SF expressed disappointment with the decision made regarding Bradridge Farm. It was noted that the concerns of DPC regarding the potential increased traffic flow and unsuitable infrastructure had also been highlighted by DCC Highways. Cllr Pannell agreed to look into the decision.
