Report from Cllr Hosking (DCC)

There has been some misinformation regarding the grants for active travel which was granted to local authorities to deal with bottle-necks where there is no room for social distancing. The money has already been committed.

A special condition has been made to grant open air hospitality venues licence from the day of application

Devon is a Beacon Authority for the test and trace initiative – the app is not yet available Eviction notices for people in arrears on rent have been extended

Access to recycling centres has now been widened to include people carriers, small vans and cars and bike with trailers (NB Bikes and trailers are expected to join the queue)

CP asked why the track and trace initiative wasn't using the established health and welfare infrastructure

No news on Gara Bridge works – Cllr Hosking to chase. He reassured that DCC were doing as much maintenance as possible whilst the roads were less busy but there were some projects that were problematic with social distancing.

SF requested that the surfacing on Clunkamoor Hill from Butterford Mill Bridge take into account that horses use the road.

JF commented on the poor condition of the road from Moreleigh to Gara Bridge. He has reported it. CP gave credit to DCC for their prompt action recently to clear a fallen tree from the highway.

The new Chief Executive has started in post

The discretionary business support scheme has gone live this week with 172 applications to date Approx. £40m has been paid out to 3,431 businesses equalling 84% of those that are eligible SF thanked the councillors for the grants for the noticeboards

Cllr Pannell warned briefly of the severe budget implications on local councils due to the pandemic A parishioner had notified SF that there was Japanese knotweed in the parish. It was noted that there are several incidences and the clerk was asked to correspond with a landowner regarding monitoring presence on the land.
