### Report from Cllr Hosking (DCC)

- Government has allocated £1b for the roll-out of 4G
- Cllr Hosking requested that the links to info. about the coronavirus provided by DCC be circulated as widely as possible

- The budget was approved with the tax on a band D property rising to £1,439.36
- Cllr Hosking still has some grant funding available closing date end September
- Devon Carbon Plan partnership has 28 stakeholders

DPC raised the on-going issue of potholes and were advised to keep on reporting them and that work is being done but there is a back-log due to the exceptional weather conditions.

Cllr Hosking will raise the subject of the reclassification of the roads in the parish to acknowledge the increased traffic flow.

Council tax

- Rising by £5. Band D from £165 £170
- There has been a steep increase in payment for policing services
- There will be a 10% average increase for towns and parishes

£400,000 has been set aside for climate change projects
