Diptford Parish Council Meeting, Parish Hall. Tuesday 10th September 2019 MINUTES

The meeting started at 7.50PM due to an overrun of the Amenity Trust meeting.

No members of the public were in attendance.

Report from County and District Councillors.

Councillor Hosking sent apologies for the meeting and requested that the following be minuted: "Cllr Hosking having recognised a potential conflict of interest with regard to representations made by businesses in connection with the Gara Bridge Chicane delegated this issue to Cllr Rufus Gilbert. Councillor Gilbert met DCC Officer Daniel Ferris at Gara Bridge on Monday 19th August 2019. I understand that, subject to redrafting, a compromise design was agreed to ensure the free passage of HGVs from Lower Hazelwood to California Cross."

Councillor Pannell clarified that DPC response to the telephone box consultation was in hand and the clerk confirmed that the response (DPC did not object to the removal of the box) had been returned. He informed DPC that SHDC are preparing for a general election, that the spending review capped council tax rises at 2% or £5.00 and that many decisions are being held until 2020 when there will be more political stability.

10.09.01	Apologies for absence were accepted from Cllr Peach
10.09.02	There were no declarations of interest in items being discussed / resolved on the Agenda.
10.09.03	The minutes of the meeting held on the 13 th August 2019, as previously circulated, were confirmed and signed by the chair.
10.09.04	Highways and Community Lengthsman

- a) It was agreed that The Lengthsman would be asked to submit final invoices for the 18 -19 work period and that councillors would review tasks ready for the new year contract.
- b) It was noted that £2,360 has been allocated to Lengthsman work for the financial year 19-20 with the HMCEF grant being £590.
- c) Gara Bridge The update from ClIr Peach was read out: The Gara Bridge chicane trial w/c 19th Aug was somewhat shortened and taken down after one day due the number of complaints, especially from local framers, regarding access by farm vehicles and machinery through the narrow chicane and over the bridge. I met Daniel Ferris, the DCC Bridge Engineer, Project leader, during the trial and have spoken to him since. He tells me that the trial was useful in so far that he obtained a better understanding of the needs of local farmers. He is now redesigning the chicane option and will be putting forward Plan B in due course for consultation which will also require a further trail at a later date.

My personal view is the two chicanes look to be an over complicated solution. The engineer however assures me that CCTV evidence informs him that damage is caused by long vehicles, and a chicane option is the best solution. I think a lot more water will pass under this bridge before we find an answer.

It was agreed to keep Gara Bridge as a standing agenda item pending further consultation and trials.

- d) The clerk has not received a response from DCC re concerns raised at last meeting and was requested to chase this up for the next meeting.
- 10.09.05 It was agreed that DPC had no objection to the withdrawal of the Council Tax Support Grant. The council has had long term notice of this and it was agreed that the amounts would have little impact on the work of the council.
