Contractors who are given the work by Highways to repair the reported potholes, do not get paid for their work until the repairs have been completed to a satisfactory standard, no matter how many times they are sent back to complete the works.

Also, an email of thanks will be sent from the Parish Council to Daniel Ferris for his work and for keeping us informed with progress updates on the camera installation.
