2022 142 Graveyard

There has been no further update on the closure of the graveyard issued

An inspection of the Graveyard has been carried out by South Hams District Council and Rob Seukula. They do not feel that the condition of the graveyard was not as bad as others they have inspected. A further inspection will be carried out with their groundsman to check the condition of the walls, boundaries, etc. Once this further inspection has been completed, then further paperwork should be sent to PCC and further forms to the Ministry of Justice, when then has to set up a 12 month notice period of closure to the wider community. Currently there is no space for burials or cremations in the graveyard.

With regards to the maintenance of the graveyard, it is currently being carried out on a voluntary basis due to the regular grass cutter being unable to continue due to health reasons. As the PCC are struggling to find a replacement, the Parish Lengthsman has expressed an interest in additional work, his contact details will be forwarded to PCC from the Clerk.

A request for further information on the closure of the Graveyard has been made to PCC who meet again in January 2023.
